EXECUTIVE ORDER NO. 012-2019

AN ORDER CREATING BARANGAY ASSESSMENT TEAM FOR SEAL OF GOOD LOCAL GOVERNANCE (SGLG)

WHEREAS, the Department of the Interior and local Government launched in 2015 the Seal of Good Local Governance (SGLG) and since then, it continuously recognizing the excellence in local governance of provinces, cities and municipalities;

WHEREAS, the DILG recognizes the role of the barangay in the overall development and transformation of the community and of the nation;

WHEREAS, the DILG through Memorandum Circular 2018-194 dated November 6, 2018 launched the Seal of Good Local Governance for Barangay;
