## EXECUTIVE ORDER NO. 019-2019

### AN ORDER RECONSTITUTING THE MUNICIPAL SCHOOL BOARD (MSB) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

**WHEREAS**, Section 98 of the Local Government of the Philippine provides for the creation of Local School Board to allow fair chance to the educational sector with regards to the operation for the maintenance, improvement and development of public school within the municipality;
