EXECUTIVE ORDER 027-2019

AN ORDER REORGANIZING THE MUNICIPAL COUNCIL FOR THE ELDERLY AND PERSONS WITH DISABILITY OF MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO AND PROVIDING FUNDS THEREOF

WHEREAS, DILG Memorandum Circular No. 2014-59 dated May 9, 2014 mandates the creation of Municipal Council for Elderly and Persons with Disability;

WHEREAS, DBM-DSWD Joint Circular No. 2003-01 dated April 28, 2003 provides for the allocation of one percent (1%) of Government Agency Budget for Programs/Projects related to Senior Citizens and Disabled;

WHEREAS, there is a need to reconstitute the council to update its membership and replace members who no longer represent the agency or organization due to retirement or end of term.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor, by virtue of the powers vested in me by Law, do hereby direct and order the reorganization of Municipal Council for Elderly and Persons with Disability of Pinamalayan, Oriental Mindoro as follows:

SECTION 1. Composition. The Municipal Council for Elderly and Persons with Disability shall be composed of the following to wit:

SECTION 2. Duties and Functions. The Municipal Council for Elderly and Persons with Disability shall perform the following duties and functions:

1. Formulate policies and adopt measures mutually beneficial to the elderly and to the community;
2. Provides incentives for non-governmental agencies and entities subject to the availability of funds
3. Allocate funds to support programs and projects that will benefit the elderly and disabled.

SECTION 3. Effectivity. This Executive Order shall take effect immediately
