EXECUTIVE ORDER NO. 029 - 2019

AN ORDER REORGANIZING THE MUNICIPAL COUNCIL FOR WOMEN OF PINAMALAYAN, ORIENTAL MINDORO PRESCRIBING ITS POWER AND FUNCTION THEREOF.

WHEREAS, the Department of Interior and Local Government in its Memorandum Circular No. 2001 – 163 mandates the creation of the Municipal Council for Women;

WHEREAS, DILG Memorandum Circular No. 2002-167 dated October 10, 2019 as amended by DILG Memorandum Circular No. 2006-125 dated September 21, 2006 prescribed guidelines relative to the creation of Local Council for Women;

WHEREAS, there is a dire need to reorganize the Municipal Council for Women due to end of term of some officers.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR. by virtue of the power vested in me by law do hereby order and direct the reorganization of the Municipal Council for Women of Pinamalayan, Oriental Mindoro as follows;

Section 1. COMPOSITION. The Municipal Council for Women shall be composed of the following members:

Section 2. POWERS AND FUNCTIONS. The Council shall exercise the following powers and functions:

- Coordinate and consolidate the efforts of the municipality/local councils of women.
- Work for the integration of the PFLCW, Inc. advocacy agenda and other relevant concerns in the provincial development plans and programs.
- Conduct meeting as the need arises.
- Coordinate, collaborate, recommend and provide the necessary support to NCRFW (now Philippine Commission of Women) and PFLCW, Inc. in the implementation of its programs.

Section 3. SECRETARIAT. The Municipal Social Welfare and Development Office II shall serve as the secretariat of the council.

Section 4. TERM OF OFFICE. The member of the council shall have a fixed term of three (3) years upon assumption of office. They shall hold office until their successors shall have been chosen and qualified.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
