## EXECUTIVE ORDER NO. 032-2019

### AN ORDER REORGANIZING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) IN PINAMALAYAN, ORIENTAL MINDORO

**WHEREAS**, Republic Act No. 9208 declares that the State shall give highest priority to the enactment of measures and development of programs that will promote human dignity, protect the people from violence and exploitation, eliminates trafficking in persons, and mitigate pressures to involuntary migration and servitude of person to ensure their recovery, rehabilitation and reintegration;

**WHEREAS**, Republic Act No. 9662 underscores the commitment of the State on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect from violence and threats to their personal safety and security.

**WHEREAS**, Section 13 of the IRR of RA 9208 and Section 59 of the IRR of RA 9262 further encourage the establishment and creation of mechanisms that shall facilitate the implementation of these laws at the local level.

**NOW THEREFORE**, I **ARISTEO A. BALDOS, JR.** Municipal Mayor, by virtue of the powers vested in me do hereby order the reorganization of Local Committee on Anti-Trafficking and Violence Against Women and Children (LCAT-VAWC) in Pinamalayan, Oriental Mindoro

**Section 2. DUTIES AND FUNCTIONS.** The Local Committee on Anti-Trafficking and violence Against Women Children (LCAT-VAWC) shall perform the following duties and functions:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local ordinances and resolution);
2. Create and establish systems on surveillance, investigation, and rescue to ensure effective and efficient coordination;
3. Undertake information education, and advocacy campaign against trafficking in person and violence against women and children;
4. Monitor and oversee the strict implementation of RA 9208, RA 9262, and other related laws for the protection of women and children, and of the Local Committee in Anti-Trafficking and Violence Against women and Children (LCAT-VAWC) national plan of action, and;
5. Implement the programs and activities as stated in the agency plan of action.

**Section 3. INSTITUTIONAL ARRANGEMENT AND COORDINATING PROCEDURES.** The Institutional Arrangements and Coordinating Procedures for the Local Committee on Anti-Trafficking and VAWC (LCAT-VAWC) shall be guided by the Section 4 of the DILG,DSWD.DOG Joint Memorandum Circular No. 2010-1 dated 18 October 2010, which provides. Creation of Local Committee on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC)
