EXECUTIVE ORDER NO. 038-2019

AN ORDER REORGANIZING THE MEMBERSHIP OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, Section 43(b) of Republic Act No. 6975, otherwise known as the DILG Act of 1990, as amended by Republic Act No. 8551, mandates the creation of People's Law Enforcement Boards (PLEBs) in every municipality;

WHEREAS, there is a need to reorganize the People's Law Enforcement Board of Pinamalayan, Oriental Mindoro in accordance with NAPOLCOM Memorandum Circular No. 2016-002;

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR. by virtue of the power vested in me by law do hereby order and direct the reorganization of the People's Law Enforcement Board (PLEB) of Pinamalayan, Oriental Mindoro as follows:

Section 1. COMPOSITION. The PLEB shall be composed of the following:

HON. RIO S. MERCENE	SB Member, Committee on Peace and Order
HON. EDGAR ABARQUEZ	Barangay Captain - Brgy. Sta. Isabel
ATTY. GAUDENCIO S. SADICON	Member, Integrated Bar of the Philippines (IBP) Oriental Mindoro Chapter
AMMAFE D. JARABE, Ed.D.	Representative from Women Sector
MR. EDELARDY FAMADICO	Principal – Sta Isabel Elementary School

The Chairperson of the PLEB shall be elected from among its members:

Section 2. FUNCTIONS, POWERS AND DUTIES. The People's Law Enforcement Board has the power to hear and adjudicate all citizen's complaints formally filed with, or referred to it, against any uniformed member of the PNP, and, if warranted, impose the corresponding penalty.

Section 3. TERM OF OFFICE. The term of office of the members of the PLEB shall be for a period of three (3) years from assumption of office. Such member shall hold office until his/her successor shall have been chosen and qualified.

The tenure of office of a PLEB Member who has been designated as such by virtue of his election to the Sangguniang Bayan or his membership with the Association of the Barangay Captains ends upon expiration of his term of office as Sangguniang Bayan Member or as a Barangay Captain. If re-elected, and subsequently redesignated to the PLEB, he must take a new oath of office.

Section 4. SECRETARIAT. Ms. Lyn T. Ozar, Administrative Assistant II under the Office of the Municipal Administrator shall serve as the Secretariat of the Board and shall assist the members in the performance of its duties and functions.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately.
