EXECUTIVE ORDER NO. 041-2019

AN ORDER CREATING SUB-COMMITTEE OF THE LOCAL INTER-AGENCY COMMITTEE FOR THE RESETTLEMENT OF INFORMAL SETTLERS IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately.
