EXECUTIVE ORDER NO. 043-2019

AN ORDER RECONSTITUTING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF PINAMALAYAN ORIENTAL MINDORO.

WHEREAS, the Municipal Development Council was already organized as mandated by Local Government Code of 1991;

WHEREAS, Section 106 of the said act provides that the MDC shall initiate the formulation of comprehensive multi-sectoral development plan and shall assist the corresponding Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, the result of 2019 National and Local Elections brought changes in the new set of local elective officials, thus the need for reorganization;

WHEREAS, the selection of Civil Society Organizations as members of the Municipal Development Council is compliant with Section 4.4 of DILG Memorandum Circular No. 2019-72 dated May 22, 2019

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipal Government of Pinamalayan, Oriental Mindoro, by virtue of the power vested in me by law do order and direct the reconstitution of the Municipal Development Council (MDC) as follows;

SECTION 1. COMPOSITION. The Municipal Development Council (MDC) in conformity with Section 107 (b) of the code, shall be composed of the following;

SECTION 2. FUNCTIONS. The Municipal Development Council shall exercise the following functions:

1. Formulate long-term, short-term, and socio-economic development plans and policies;
2. Formulate medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and directions of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Each MDC member shall, as far as practicable, participate in at least one functional/sectoral committee;
7. Perform such other functions as may be provided by law or competent authority.

SECTION 3. CREATION OF EXECUTIVE COMMITTEE. The local development councils, by council resolution, shall create an Executive Committee. It shall be chaired by the Municipal Mayor and shall be composed of the following members:

SECTION 4. POWERS, FUNCTIONS AND RESPONSIBILITIES OF THE EXECUTIVE COMMITTEE. The Executive Committee shall have the following powers, functions and responsibilities:

1. Ensure that the decisions of the Council are faithfully and effectively carried out;
2. Act on matters that need the immediate attention and/or action of the Council;
3. Formulate policies in accordance with the general principles laid down by the Council; and
4. Act on other matters which the Council, by resolution, may so authorize.

SECTION 5. CREATION OF FUNCTIONAL/SECTORAL COMMITTEES. To assist the council in the performance of its functions, functional/sectoral Committees are hereby created, namely; Economic Services, General Public Services, Physical and Utilities Services and Environmental Management Services.

SECTION 6. FUNCTIONS OF FUNCTIONAL/SECTORAL COMMITTEE. Consistent with national policies and standards, the Functional/Sectoral Committees shall:

- a. Provide the LDC with data and information essential to the formulation of plans, programs, and activities.
- b. Define functional/sectoral objectives, set targets and identify programs, projects and activities for the particular sector or function;
- c. Collate and analyze information and statistics and conduct related studies;
- d. Conduct public hearings on vital issues affecting the functions/sector
- e. Coordinate planning, programming, implementation of programs, projects, and activities within each sectors;
- f. Monitor and evaluate programs and projects; and
- g. Perform such other functions as may be assigned by the LDC.

SECTION 7. SECRETARIAT. The Municipal Planning and Development Office shall act as Secretariat and shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharged of its functions. It shall be headed by the Municipal Planning and Development Coordinator (MPDC).

SECTION 8. MEETINGS. The MDC shall meet at least once every six (6) months or as often as may be necessary.

SECTION 9. EFFECTIVITY. This Executive Order shall take effect immediately.
