EXECUTIVE ORDER NO. 049-2019

AN ORDER REACTIVATING THE LOCAL PRICE COORDINATING COUNCIL (LPCC) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Republic Act No. 7581 provides for the protection of consumers by prescribing measures against undue price increases during emergency situations;

WHEREAS, DILG issued Memorandum Circular No. 2018-128 encouraging all Local Chief Executives to reactivate their Local Price Coordinating Councils (LPCCs) to address or forestall and to monitor exorbitant, excessive, and unreasonable price increases of essential prime commodities.

NOW THEREFORE, I, **ARISTEO A. BALDOS, JR.**, Municipal Mayor by virtue of the powers vested in me by law, do hereby order the reactivation of Local Price Coordinating Council (LPCC) in the Municipality of Pinamalayan, Oriental Mindoro, as follows:

Section 2. DUTIES AND FUNCTIONS. The Local Price Coordinating Council shall perform the following duties and functions:

1. Coordinate and rationalize programs of member agencies in the respective municipalities to stabilize prices and supply of basic necessities and prime commodities
2. Recommend to the National Price Coordinating Council or to the implementing agencies suggested retail prices of basic necessities and prime commodities;
3. To conduct in-depth analysis on the causes of price fluctuations, and
4. To recommend steps to correct unwarranted price increases and supply shortages.

Section 3. SECRETARIAT. The following personnel shall serve as the Secretariat and shall assist the Council in the exercise of its functions like the recording of its proceedings, transcribing the records of the proceedings,
