EXECUTIVE ORDER NO.06-2019

AN ORDER CREATING AN AD HOC COMMITTEE TO SERVE AS TECHNICAL WORKING GROUP IN THE DEVELOPMENT OF THE LOCAL COMPREHENSIVE EMERGENCY PROGRAM FOR CHILDREN IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, pursuant to RA 7160 otherwise known as the Local Government Code of 1991, LGUs are mandated to ensure the general welfare of their constituents and to provide basic social services, among others, for the care of abandoned minors, abused children, juvenile delinquents, drug dependents, and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age;

WHEREAS, the Philippines is prone to disasters and calamities wherein during these emergency situations, children are the most vulnerable and at higher risk to diseases and deaths, and, worst affected by food insecurity, disrupted schooling, homelessness, and separation from families;

WHEREAS, given the vulnerability of children to natural and human-induced emergency situations, RA 10821 otherwise known as the Children's Emergency Relief and Protection Act was enacted to protect the fundamental rights of children before, during, and after disasters and other emergency situations when children are gravely threatened or endangered by circumstances that affect their survival and normal development;

WHEREAS, under the aforesaid law, local government units are mandated to formulate Comprehensive Emergency Programs for Children (CEPC) that abide with humanitarian standards in handling disasters and other emergency situations for the protection of children, pregnant and lactating mothers.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, by virtue of the power vested in me by law do hereby order the creation of Ad Hoc Committee to serve as the Technical Working Group in the Development of the Local Comprehensive Emergency Program for Children in the Municipality of Pinamalayan, Oriental Mindoro as follows:

The LDRRM Office shall serve as the lead office in the planning, implementation, monitoring and reporting of the Local CEPC, in coordination with the Municipal Planning and Development Office and Municipal Social Welfare and Development Office.

SECTION II. DUTIES AND RESPONSIBILITIES. The Ad Hoc Committee shall perform the following duties and responsibilities.

1. Develop its timeline for the development of Local CEPC;
2. Convene a series of consultation workshops to formulate the draft local CEPC;
3. Present and submit the draft Local CEPTS to the LCE for approval

SECTION III. FUNDING. Budget allocation for the Local CEPC can be drawn from a share or portion of funds from any or among the following the other sources based on existing guidelines for utilization:

1. LDRRM Fund;
2. Local Development Fund;
3. Gender and Development Fund;
4. Special Education Fund;
5. Other Local Government Sources

Section IV. EFFECTIVITY. This Executive Order shall take effect immediately.
