EXECUTIVE ORDER NO. 001-2020

AN ORDER ORGANIZING A TEAM OF RAPID DAMAGE ASSESSMENT AND NEEDS ANALYSIS (RDANA) PRACTITIONERS IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, Republic Act 10121 mandates the institutionalization of RDANA as tool for disaster response;

WHEREAS, at present, only few members of Municipal Disaster Risk Reduction and Management Council (MDRRMC) are qualified to conduct RDANA;

WHEREAS, this Municipality is located in an island prone to national disasters like typhoon, tsunami and earthquake;

WHEREAS, after the occurrence of every disaster, it is important to have a response group responsible for the determination of its immediate impacts to properly address the priority needs of the affected community;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the organization of a Team of Rapid Damage Assessment and Needs Analysis (RDANA) Practitioners in the Municipality of Pinamalayan, Oriental Mindoro as follows:

Section 2. DUTIES AND FUNCTIONS. The Team of RDANA Practitioner shall perform the following duties and functions:

- Provide quick snapshot of the disaster situation by conducting initial assessment of the situation on the ground. They shall determine the type and extent of damages brought about by disaster, including its second threats, the critical needs of the affected population, and the local response capacities.
- 2. Attend trainings, seminars and workshops;
- 3. Perform additional tasks as may be deemed necessary.

Section 3. EFFECTIVITY. This Executive Order take effect immediately.
