EXECUTIVE ORDER NO. 011- 2021

AN ORDER PRESCRIBING THE RULES AND REGULATIONS FOR THE DOMESTIC TOURISTS AND LOCAL TOURISM ESTABLISHMENT IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, President Rodrigo Roa Duterte issued Proclamation 1021 extending the declaration of State Calamity throughout the Philippines for a period of one (1) year, effective 13 September 2020 to 12 September 2021, unless earlier lifted or extended as circumstances may warrant due to Corona Virus Disease 2019;

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases Resolution No. 101 series of 2021 dated February 26, 2021 provides that the Travel Authority issued by Joint Task Force COVID Shield and health certificates shall no longer be required in travelling in any provinces;

WHEREAS, the Provincial Governor of Oriental Mindoro issued Executive Order No. 011 series of 2021 on March 12, 2021 providing rules and procedures for domestic tourists entering and travelling in the Province of Oriental Mindoro;

WHEREAS, on 22 March 2021, the COVID-19 Local Task Force virtually convened, and thereafter issued recommendations for the guidelines to be observed by domestic tourists and local tourism establishments in the Municipality of Pinamalayan, Oriental Mindoro due to increasing number of COVID cases in the municipality.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in my by law, do hereby promulgate this executive order as follows:

1. Prior to the scheduled date of travel, Domestic Tourist should register first at the Municipal Disaster Risk Reduction and Management Office (MDRRMO) online registration portal: pinamalayan.gov.ph/hdf and submit the following requirements:
 - a. Valid ID with picture
 - b. Health Declaration Form
2. Domestic Tourists should wait for the text confirmation from the MDRRMO-Pinamalayan before going to travel;
3. All Domestic Tourists shall be required to present COVID-19 RT-PCR Test issued within 48 hours prior to arrival at the port and/or point of destination.

SECTION 2. GENERAL GUIDELINES FOR THE TOURISM ESTABLISHMENT. All tourism-related establishment especially those who are offering accommodations shall continuously observe the strict compliance of its staff and guests to government-imposed guidelines and basic health protocols against COVID-19 such as:

1. Establishments should facilitate the registration of their guests using logbooks and/or use of tracking app STAYSAFE;
2. No Face Mask, No Entry Policy to all establishment;
3. Daily body temperature test of all the staff and guests;
4. Those who will inhibit symptoms of COVID-19 shall be reported to Barangay health Emergency Response Team (BHERT) for proper response;
5. Reminder signs shall be installed in strategic locations;
6. Frequent sanitation and disinfection of high-touch surfaces in the beach area must be conducted;

7. Trash bins must be available and accessible. A separate trash bag or bin must be provided for used PPE, such as used facemasks, gloves and other sanitation waste materials;
8. In the operation of tourism sites the new carrying capacity will be site-specific and shall be determined by the allowable number of guests per tour group per day;
9. Outdoor non-contact sports and other forms of exercise such as swimming, surfing, running and walking are allowed provided that minimum public health standards are observed;
10. Biking may be allowed if bike paths are available;
11. To make sure that guidelines and health protocols are consistently and strictly imposed, there will be a monitoring, evaluation and enhancing team.

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately.
