EXECUTIVE ORDER NO. 013 -2016

REORGANIZING THE MUNICIPAL PEACE AND ORDER COUNCIL

WHEREAS, Section 116, of Republic Act No. 7160 otherwise known as Local Government Code of 1991 provides for the organization of the Local Peace and Order Council;

WHEREAS, Executive Order No. 773 dated January 5, 2009 further reorganized the Peace and Order Councils on the national, provincial, city and municipal levels of government;

WHEREAS, this local special body is co-terminus with the term of LCE;

WHEREAS, with the assumption of the new set of Municipal Officials elected during the May 09, 2016, under a new Administration, there is a need to reorganize the Pinamalayan Municipal Peace and Order Council;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the power vested in me by law do order and direct the reorganization of the Municipal Peace and Order Council (MPOC) as follows:

The composition of the Peace and Order Council shall be by office or sector represented by its incumbent official/representative.

Section II. MEETING. The Council shall meet every last Thursday of the month at 3:00 p.m. at the Conference Hall or on a date and time as maybe determined by the members.

If for any unavoidable circumstances an MPOC member cannot attend a meeting, he cansend an official representative who can speak for his office or sector.

Section III. SECRETARIAT. The Municipal Local Government Operation Officer shall act as the secretary of the council and shall be assisted in its functions and duties by the regular staff of the MPOC chairman.

Section IV. EFFECTIVITY. This Executive Order supersedes all previous Executive Orders issued to this effect, and same shall take effect immediately with copies furnished all members for their information and guidance.
