EXECUTIVE ORDER NO. 13- 2021

AN ORDER ORGANIZING THE MUNICIPAL MULTIPARTITE ENVIRONMENTAL IMPACT ASSESSMENT MONITORING TEAM (MMEIAMT) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, every local government unit is mandated to exercise powers that are essential for the promotion of the general welfare of the people within their respective territorial jurisdiction and for the enhancement of the right of the communities to a balanced ecology;

WHEREAS, the Department of Environment and Natural Resources (DENR) Administrative Order No. 2003-30 mandated the creation of Multipartite Monitoring Team (MMT) to monitor compliance with the conditions of Environmental Compliance Certificate (TECC) and ensure balance between socio-economic development and environmental protection for the benefit of the populace.

WHEREAS, it is the policy of the Municipal Government of Pinamalayan to ensure consistency with the principles of sustainable development and responsible stewardship of the environment and natural resources;

WHEREAS, the Municipal Government of Pinamalayan through MMEIAMT is committed to make sure that ecological integrity and peoples' health, safety and livelihood will not be sacrificed amid the development activities within its territorial jurisdiction.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor, by the virtue of the powers vested in me by the law, do hereby order the organization of the Municipal Multipartite Environmental Impact Assessment Monitoring Team (MMEIAMT) of the Municipality of Pinamalayan, Oriental Mindoro, as follows:

SECTION 2. FUNCTIONS AND DUTIES. The MMEIAMT shall perform the following functions and duties:

- Monitor project compliance with the Environmental Compliance Certificate (EEC) conditions, Environmental Management Plan and the completeness of permits issued by concerned agencies.
- Participate in public consultations/ hearings and gather relevant information to determine cause of damage and respond to public complaints regarding the project;
- 3. Participate in law enforcement, including the closure of the establishment/projects;
- Conduct an annual inventory of existing establishments/projects within the jurisdiction to ascertain whether they have to be required to apply for ECC or not based on the status of their projects;
- 5. Undertake public information and education dissemination; and
- Prepare, integrate and disseminate monitoring reports and submit to the Municipal Mayor and to other concerned agencies such as DENR and Provincial Government through Provincial Mining Regulatory Board (PMRB) and PG-ENRO.

Section 3. SECRETARIAT. The Municipal Environment and Natural Resources Office (MENRO) shall serve as Secretariat to the MMEIAMT, which shall provide technical assistance and administrative support to the Team.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
