**EXECUTIVE ORDER NO. 015-2021**

**AN ORDER TEMPORARILY PROHIBITING THE CONDUCT OF NON-ESSENTIAL MASS/PUBLIC GATHERINGS IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.**

**WHEREAS**, Section 5 of Inter- Agency ask Force for the Management of Emerging Infectious Diseases Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with amendments as of April 3, 2021 states that gatherings shall be allowed up to fifty percent (50%) of the seating or venue capacity provided, that participants shall strictly observe the minimum public health standards, and the establishments or venues where the gatherings will take place shall strictly comply with ventilation standards as provided for under relevant issuances of the Department of Labor and Employment (DOLE);

**WHEREAS**, the DILG Memorandum Circular No. 2021-50 dated May 5, 2021 provides for the roles of Local Chief Executive in the implementation of minimum public health standards especially on the prohibition against public or mass gathering;

**WHEREAS**, the conduct of non-essential gatherings are strictly prohibited in accordance with Executive Order No. 16 series of 2021 issued by the Provincial Governor on April 10, 2021;

**WHEREAS**, with the increasing number of COVID-19 cases in the locality, the members of the Local Task Force during a virtual meeting on May 12, 2021 unanimously recommended to temporarily prohibit the conduct of non-essential mass/public gatherings or crowd drawing activities which are considered as one of the super-spreader events;

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR.**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in my by law, do hereby temporarily prohibit the conduct of non-essential mass/public gatherings in the Municipality of Pinamalayan, Oriental Mindoro.

**Section 1. PROHIBITION.** With the increasing number of COVID-19 cases, all non-essential mass/public gatherings regardless of number of attendees conducted by private and government agencies in the municipality are temporarily prohibited consistent with Section 8 of Provincial Executive Order No. 16 Series of 2021.

**Section 2. IMPLEMENTATION.** The Pinamalayan Municipal Police Station (MPS) thru Chief of Police (COP) and the Barangay Captains are hereby mandated to strictly implement the provision of this Order.

The Public is encouraged to monitor and report violations of coronavirus health protocols especially incidents of mass gatherings in this municipality at Pinamalayan Police Station Hotline 0915-5915904.

**Section 3. SANCTION.** Persons and entities found violating this Order shall be subjected to administrative and judicial prosecution, including cancellation of business permit, in accordance with all existing applicable laws and ordinances.

**Section 4. EFFECTIVITY.** This Order shall take effect on May 18, 2021 until September 12, 2021, unless lifted or amended by the Local Chief Executive as the circumstances may warrant upon recommendation of the Covid-19 Local Task Force.
