EXECUTIVE ORDER NO. 016 - 2016

AN ORDER RECONSTITUTING THE MEMBERSHIP OF THE MUNICIPAL SCHOOL BOARD (MSB) IN THE MUNICIPALITY OF PINAMALAYAN, PROVINCE OF ORIENTAL MINDORO.

WHEREAS, Section 116 of Republic Act No. 7160 otherwise known as Local Government Code of 1991 provides for the organization of the Municipal School Board;

WHEREAS, this local special body is co-terminus with the term of the Local Chief Executive;

WHEREAS, with the assumption of the new set of Municipal Officials elected during the May 09, 2016, there is a need to reconstitute the Municipal School Board;

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the power vested in me by law do order and direct the reconstitution of the Municipal School Board (MSB) as follows:
