EXECUTIVE ORDER NO. 017-2016

AN ORDER RECONSTITUTING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF PINAMALAYAN ORIENTAL MINDORO.

WHEREAS, the Municipal Development Council is among the local special bodies mandated under Title Six of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Section 106 of said Act provides that the MDC shall initiate the formulation of comprehensive multi-sectoral development plan and shall assist the corresponding Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, there is a need to reconstitute the said body following the assumption to office of a new Administration.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipal Government of Pinamalayan, Oriental Mindoro, by virtue of the power vested in me by law do order and direct the reconstitution of the Municipal Development Council (MDC) as follows;

B. FUNCTIONS

The Municipal Development Council shall exercise the following functions:

1. Formulate long-term, short-term, and socio-economic development plans and policies;

2. Formulate medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and directions of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Each MDC member shall, as far as practicable, participate in at least one functional/sectoral committee;
7. Perform such other functions as may be provided by law or competent authority.

C. MEETINGS

The MDC shall meet at least once every six (6) months or as often as may be necessary.

D. SECRETARIAT

The Municipal Planning and Development Office shall act as Secretariat and shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharged of its functions. It shall be headed by the Municipal Planning and Development Coordinator (MPDC).

E. FUNCTIONAL/SECTORAL COMMITTEES

To assist the council in the performance of its functions, functional/sectoral Committees are hereby created, namely; Economic Services, General Public Services, Physical and Utilities Services and Environmental Management Services.

E.1. Composition of the Functional/Sectoral Committees shall be officials and/or authorized representatives from sub-sectors concerned, as follows:

a. ECONOMIC SERVICES

- Agriculture Development
- Trade and Industry
- Tourism Development and Promotion
- Local Economic Enterprise

b. SOCIAL SERVICES

- Education and Manpower Development
- Health , Nutrition and Population Control
- Labor and Employment
- Housing and Community Development
- Social Security, Social Services and Welfare
- Peace and Order

c. GENERAL PUBLIC SERVICES

- Governance
- Development Administration

d. PHYSICAL AND UTILITIES SERVICES

- Infrastructure Development
- Electric and Power Services
- Water and Sewerage Services
- Communication and Information Technology
- Public Transportation
- Irrigation System

e. ENVIRONMENTAL MANAGEMENT SERVICES

- Environment Protection
- Land Use and Zoning Administration
- Natural Resources Management and Pollution Control
- Waste Management and Pollution

E.2. Consistent with national policies and standards, the Functional/Sectoral Committees shall:

- Provide the LDC with data and information essential to the formulation of plans, programs, and activities.
- Define functional/sectoral objectives, set targets and identify programs, projects and activities for the particular sector or function;
- Collate and analyze information and statistics and conduct related studies;
- Conduct public hearings on vital issues affecting the functions/sector
- Coordinate planning, programming, implementation of programs, projects, and activities within each sectors;
- Monitor and evaluate programs and projects; and
- Perform such other functions as may be assigned by the LDC.

F. EFFECTIVITY

This Executive Order shall take effect immediately.
