EXECUTIVE ORDER NO. 018 - 2016

AN ORDER CREATING THE PINAMALAYAN MUNICIPAL COUNCIL FOR THE WELFARE OF CHILDREN (PMCWC) AND BARANGAY COUNCILS FOR THE PROTECTION OF CHILDREN (BCPC) IN THE MUNICIPALITY OF PINAMALAYAN, PROVINCE OF ORIENTAL MINDORO.

WHEREAS, Republic Act No. 7610 (Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act) provides for stronger deterrence and special protection against child abuse, exploitation and discrimination, and its corresponding penalties;

WHEREAS, Article 87 of PD 603 (Children and Youth Welfare Code) states that every barangay council shall encourage the organization of a Local Council for the Protection of Children (LCPC).

WHEREAS, Ordinance No. 016-2008 provides for the creation and composition of the Pinamalayan Municipal Council for the Welfare of Children (PMCWC) and Barangay Councils for the Protection of Children (BCPC).

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the power vested in me by law do order and direct the creation of Pinamalayan Municipal Council for the Welfare of Children and Barangay Councils for the Protection of Children as follows;

Section I. CREATION. The Pinamalayan Municipal Council for the Welfare of Children and Barangay Council for the Protection of Children are hereby created as mandated under Ordinance No. 16-2008.

Section II. **COMPOSITION.** The Municipal Council for the Welfare of Children shall be composed of the following:

Section VI. EFFECTIVITY. This Executive Order shall take effect immediately upon approval hereof.
