EXECUTIVE ORDER NO. 019-2020

AN ORDER CREATING SUPPORT GROUP FOR THE PREPARATION OF LIVELIHOOD RECOVERY PROJECT PROPOSAL NEEDED FOR THE IMPLEMENTATION OF LIVELIHOOD ASSISTANCE GRANT (LAG) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Republic Act No. 11469 or the Bayanihan Heal as One Act, has placed the country in a State of National Emergency;

WHEREAS, DSWD Memorandum Circular No. 09 series of 2020 provides for the Omnibus Guidelines in the implementation of the Emergency Subsidy Program of the Department of Social Welfare and Development in which provision of Livelihood Assistance Grants (LAG) to families qualified as "low-income households is one of the social amelioration measure;

WHEREAS, there is a need to create a Support Group to assist the Municipal Social Welfare and Development Office (MSWDO) in the preparation of project proposal to fast track the implementation of Livelihood Assistance Grant;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the creation of Support Group for the preparation of Livelihood Recovery Project Proposal needed for the implementation of Livelihood Assistance Grant (LAG) in the Municipality of Pinamalayan, Oriental Mindoro :

Section 1. COMPOSITION. The Support Group shall be composed of the following:

Section 2. FUNCTIONS. The Support Group shall be responsible in the preparation of Livelihood Recovery Project Proposal using the template prescribed by the Department of Social Welfare and Development (DSWD).

They shall also perform other duties and functions as may be deemed necessary in the implementation of Livelihood Assistance Grant.

Section 3. EFFECTIVITY. This Executive Order take effect immediately.
