EXECUTIVE ORDER NO. 021 - 2016

AN ORDER CREATING THE TECHNICAL WORKING GROUP (TWG) TO STUDY AND RECOMMEND THE TRAFFIC MANAGEMENT PLAN IN THE COMMERCIAL DISTRICT OF MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Republic Act No. 7160 otherwise known as Local Government Code of 1991 empowered local government units, among others, to regulate traffic on all streets and bridges within their respective boundaries;

WHEREAS, there is an imperative need for the Local Government Unit of Pinamalayan to provide traffic management plan to address the traffic congestion in its commercial district.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the power vested in me by law do order and direct the creation of Technical Working Group and Secretariat as follows:

Section II. FUNCTION OF TWG.

- 1.Conduct coordination meetings and data gathering in the restructuring of the the loading, unloading and parking areas of motor vehicles in the commercial district of the municipality.
- Review existing ordinance related to traffic on land transportation for the purpose of recommending to the Local Chief Executive, policies and measures to address the traffic situation in the main thoroughfares of Pinamalayan.
- Based on the aforesaid study, prepare and submit the draft of Traffic Management Plan within the third quarter of 2016 for the approval of the Local Chief Executive and the Sangguniang Bayan.

SECTION III. SECRETARIAT. The Secretariat shall be the Special Concerns Services. The Secretariat shall record and document all the proceedings of the meetings, manage all administrative requisites of the TWG and perform all other functions as may be deemed necessary.

SECTION IV. FUND.Expenses to complete the Traffic Management Plan shall be sourced from any available fund subject to accounting and auditing rules.

SECTION V. EFFECTIVITY. This Executive Order shall take effect immediately.
