EXECUTIVE ORDER NO.021-2017

AN ORDER CREATING THE TOURISM PLANNING COMMITTEE OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, local governments are mandated by the Local Government Code of 1991 otherwise known as R.A. 7160 to develop and promote tourism and the general welfare in their respective jurisdictions;

WHEREAS, DILG Memorandum (MC) No. 95-162, encouraged Local Chief Executive (LCEs) to organize Tourism Councils in their jurisdictions, composed of government and private sector representatives to formulate programs and recommendations to develop local tourism facilities and attractions tapping local resources and funds;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order and direct the creation of the Tourism Planning Committee as follows:

Section II. DUTIES AND FUNCTIONS. The Tourism Planning Committee shall perform the following duties and functions:

- 1. Prepare a work plan for the preparation of the tourism plan
- 2. Formulate the tourism plan
- 3. Consult with residents and other stakeholders of tourism areas

The Chairperson shall have the principal responsibility for directing and overseeing the development of the tourism plan, according to the schedule. The chairperson is responsible for chairing major tourism planning sessions, and shall designate a representative in the sessions that he will not be present.

The Committee shall actively participate in all activities identified in the work plan. The team shall develop realistic goals, appropriate strategies and identify

programs, projects and activities that best contribute to the attainment of the tourism goals and objectives of the locality.

Section III. FUNDING. The budgetary requirements for the conduct of activities and delivery of outputs shall be sourced from local funds.

Section IV. EFFECTIVITY. This Executive Order shall take effect immediately.
