EXECUTIVE ORDER NO. 022-2018

AN ORDER CREATING THE PRE-MARRIAGE COUNSELING (PMC) TEAM OF PINAMALAYAN, ORIENTAL MINDORO PRESCRIBING ITS POWER AND FUNCTION THEREOF

WHEREAS, pursuant to Presidential Decree 965, all municipalities are enjoined to organize Pre-Marriage Counseling teams and implement the PMC Program for the efficient delivery of the PMC Program services;

WHEREAS, Joint Memorandum Circular No. 01 Series of 2010 of the Department of the Interior and Local Government, Department of Health, Department of Social Welfare and Development and Commission on Population orders all Local Chief Executives for the amendments of the Revised Pre-Marriage Counseling (PMC) Program Implementing Guidelines of 2002;

WHEREAS, the Municipal Government of Pinamalayan recognizes the significant role of parents in shaping the future of Filipino children, thus, firmly believes that providing for a uniform, effective and comprehensive pre-marriage counseling to would-be couples and parents in Pinamalayan can be reached only by means of organizing a Pre-Marriage Counseling Team which shall act to carry out the said responsibilities;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, by virtue of the power vested in me by law do hereby order the creation of Pre-Marriage Counseling (PMC) Team in the Municipality of Pinamalayan, Oriental Mindoro as follows:

Section I. Composition. The PMC Team shall be composed of the following members:

Section II. Duties and Functions. The PMC Team shall perform the following duties and functions:

- 1. Develop and maintain a responsive mechanism to effectively implement the Pre-Marriage Counseling Program in the municipality;
- 2. Advocate for the effective implementation of the Pre-Marriage Counseling Program to ensure continued awareness and support for the program;
- 3. Undertake preparatory activities for the Pre-Marriage Counseling session by:

- a. Disseminating information about the PMC program through the radio, community assemblies, barangay meetings, and other media outlets;
- b. Posting schedules of the PMC sessions in the Office of the Local Civil Registrar, Offices of the mandatory members of the PMC Team, and other noticeable places in the municipal hall.
- c. Ensuring appropriateness, readiness and availability of a venue for PMC session;
- d. Preparing schedules of PMC sessions for mandatory team members to enable them to plan those activities;
- e. Ensuring the availability of PMC supplies and materials;
- 4. Conduct a PMC session to not more than 15 couples at a time;
- 5. Issue PMC Certificates which are signed by accredited mandatory PMC Team members to engaged couples who have completed the PMC sessions

Section III. Effectivity. This Executive Order shall take effect immediately.
