EXECUTIVE ORDER NO. 024-2016

AN ORDER CREATING THE PINAMALAYAN ENVIRONMENTAL PROTECTION COUNCIL (PEPC) AND DEFINING THE FUNCTIONS THEREOF

WHEREAS, the local government is fully aware of the continuing deterioration of the environment caused by rapid urbanization, population expansion, natural resources extractions, the use of modern technology and other socioeconomic factors;

WHEREAS, the local government is cognizant of the damaging and irreversible environmental impacts of these socio-economic activities on the stability of natural ecosystems and on human health and safety as well as on the natural resources of this municipality;

WHEREAS, it is the desire of local government to create, develop, maintain and improve conditions under which man and nature can thrive in productive and enjoyable harmony with each other, and thereby attain an environmental quality conducive to a life of dignity and well-being for our people;

WHEREAS, there is a need to create Pinamalayan Environmental Protection Council that will oversee, unify and integrate the planning, management and implementation of the local government's environment program.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me, do hereby order and direct the following:

Section I.CREATION. There is hereby created a Pinamalayan Environmental Protection Council, hereinafter referred to as the "PEPC".

Section III. FUNCTION.

- A. Recommend programs to achieve more effective protection and enhancement of environmental quality;
- B. To recommend new legislation or amendments to existing ones to cope with the changes in the environment status of the municipality;
- D. To monitor development projects initiated by government and private agencies and to see to it that they are in line with priorities of the local government on environmental protection;
- D. To initiate a continuing educational and training campaign programs on the enhancement of the quality of life through environmental improvement;
- E. To perform such other functions deemed necessary.

Section III. SECRETARIAT. The MENRO shall be the secretariat.

Section IV. MEETING. The regular meeting shall be held quarterly or on the schedule agreed by the members.

Section IV. EFFECTIVITY. This order shall take effect immediately.
