EXECUTIVE ORDER NO. 24-2017

APPOINTMENT OF FISH WARDEN/BANTAY DAGAT IN THE MUNICIPALITY OF PINAMALAYAN, PROVINCE OF ORIENTAL MINDORO

WHEREAS, R.A. 7160, otherwise known as Local Government Code of 1991, mandates the local government unit to adopt measures to protect the coastal and marine environment within their respective jurisdiction;

WHEREAS, R.A. 8550, Philippine Fisheries Code of 1998, similarly mandates the local government units to enforce laws and regulations relative to the protection of the coastal and marine resources;

WHEREAS, the primary consideration in the successful enforcement of fisheries and environmental laws is the active participation of the municipal fisher folks community;

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section II. Functions and Duties of Deputized Fish Warden/Bantay Dagat. As deputized Fish Warden/Bantay Dagat, the above named persons are authorized:

1. To enforce fisheries and environmental laws in the coastal areas of the Municipality of Pinamalayan, Province of Oriental Mindoro;
2. To do citizen arrest as provided by the rules, regulations and laws in the Rules of Court;
3. To sign activity reports relative to the performance of their functions and duties as deputized fish warden/bantay dagat;
4. To file complaints against illegal fishers and environmental cases in the proper venue;
5. Perform other functions that may deem necessary.

Section III. Secretariat. The Office of the Municipal Agriculturist shall serve as the focal office or secretariat of the Fish Warden or Bantay Dagat Team and shall perform the following functions:

1. Assist the team in enforcing fisheries and environmental laws in the coastal areas of the Municipality of Pinamalayan;
2. Assist the team in apprehending fishery laws violators;
3. Monitor the performance of the Bantay Dagat Team;
4. Provide technical assistance such as trainings, mentoring and coaching relative to the performance and functions as deputized fish warden/bantay dagat;
5. Perform other functions that may deem necessary.

Section IV. Honoraria. Appointed Fish Warden/Bantay Dagat shall receive an honoraria amounting to five hundred pesos monthly, subject to availability of funds.

Section V. Repealing Clause. All prior issuances on the appointment of Fish Warden/Bantay Dagat inconsistent herewith shall be deemed superseded by this Order.

Section VI. Effectivity. This Order shall take effect immediately.
