**EXECUTIVE ORDER NO. 025-2017**

**AN ORDER CREATING SMOKE FREE TASK FORCE IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.**

**WHEREAS**, the Municipal Government of Pinamalayan adopts Executive Order No. 26 dated May 2, 2017 mandating the establishment of smoke free environments in public places and enclosed areas;

**WHEREAS**, Ordinance No. 03-2013 Chapter V Article C prohibits smoking inside passenger jeeps, buses, and other passenger vehicles, gymnasiums, municipal session hall, movie houses, and other public places unless there is a designated smoking area;

**WHEREAS**, the Municipal Government of Pinamalayan recognizes that public health takes precedence over any commercial or business interest;

**WHEREAS**, the creation of smoke free task force is necessary to carry out the provisions of EO 26 and Municipal Ordinance No. 03-2013


Pinamalayan Smoke Free Task Force and Chief of Police of Pinamalayan Municipal Police Station are hereby directed to carry out the provisions of RA 9211, including the apprehension of violators and institution of criminal proceedings for violation of RA 9211, in accordance with relevant laws, rules and regulations, ordinances, and strictly observing due process

**Section II. Smoking Cessation Program.** The Municipal Health Officer shall spearhead the formulation, promotion and implementation of the Smoking Cessation Program consistent with the National Smoking Cessation Program established pursuant to RA 9211.

**Section III. Penalties.** Violators shall be liable and be punished in accordance with the governing provisions of Republic Act No. 9211 and other applicable laws and ordinances.

**Section IV. Effectivity.** This Order shall take effect immediately.
