EXECUTIVE ORDER NO. 025-2018

AN ORDER CREATING THE MUNICIPAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) TEAM TECHNICAL WORKING GROUP AND DESIGNATING THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER III AS TRANSPORT CZAR OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, the Municipal Public Transport Route Plan Team of Pinamalayan, Oriental Mindoro was created by virtue of Executive Order No. 040-2017 dated December 28, 2017;

WHEREAS, public transport groups in the Province of Oriental Mindoro raised their concerns in franchise issuance and the need to implement an efficient transport system provincewide;

WHEREAS, creation of Technical Working Group is vital in the consolidation of pertinent information relevant to the crafting of MPTRP of Pinamalayan, Oriental Mindoro;

NOW THEREFORE, I ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of power vested in me by law do hereby order and direct the creation of Municipal Public Transport Route Plan Team Technical Working Group and the designation of Local Disaster Risk Reduction and Management Officer III as the Transport Czar of Pinamalayan, Oriental Mindoro, as follows:

Section 1. TRANSPORT CZAR. Mr. Marlo Rosales, Local Disaster Risk Reduction and Management Officer III is hereby designated as Transport Czar who shall oversee transport concerns relating to franchise issuance of Land Transportation Franchising and Regulatory Board (LTFRB) for the municipality.

- c. Draft the Municipal Public Tranport Route Plan as guided by the LPTRP Manual; and,
- d. Concerned with other concerned Offices/Bureau

Section 3. SUBMISSION OF DRAFT LOCAL PUBLIC TRANSPORT ROUTE PLAN. The MPTRP Team and the Technical Working Group shall submit the draft Local Public Transport Route Plan to the MPTRP Chairperson within two (2) months upon the effectivity of this Executive Order

Section 4. EFFECTIVITY. This order shall take effect immediately.
