### **EXECUTIVE ORDER NO. 026- 2020**

**AN ORDER AMENDING SECTION 5 OF EXECUTIVE ORDER NO. 025-2020 "AN ORDER IMPOSING TOTAL LOCKDOWN IN BARANGAY LUMAMBAYAN, PINAMALAYAN, ORIENTAL MINDORO FOR PURPOSES OF CONTACT TRACING, TESTING AND DISEASE SURVEILLANCE".**

**WHEREAS**, Executive Order No. 025-2020 was issued on September 5, 2020 imposing total lockdown in Barangay Lumambayan, Pinamalayan, Oriental Mindoro for purposes of Contact Tracing, Testing and Disease Surveillance;

**WHEREAS**, on 06 September 2020 at around 11:00 o'clock in the morning, a meeting with the barangay officials of Barangay Lumambayan was conducted by Pinamalayan Municipal Police Station facilitated by PLTCOL Anthony J. Ramos to discuss the implementation of the said Order;

**WHEREAS**, during the meeting, it was agreed to enforce a total lockdown measure to combat local transmission of COVID-19 which necessitates the amendment of Section 5 "*Vehicles going to neighboring barangays shall be allowed entry to or exit from Barangay Lumambayan provided that no stopover shall be made therein*";

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR.**, Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the amendment of Executive Order No. 025-2020 "*AN ORDER IMPOSING TOTAL LOCKDOWN IN BARANGAY LUMAMBAYAN, PINAMALAYAN, ORIENTAL MINDORO FOR PURPOSES OF CONTACT TRACING, TESTING AND DISEASE SURVEILLANCE*" specifically Section 5 thereof.

Relative to this, Section 5 is hereby amended to read as follows:

**Section 5.** No vehicles shall be allowed entry to or exit from Barangay Lumambayan, Pinamalayan, Oriental Mindoro except those Authorized Person Outside of Residence (APOR) mentioned in Section 3. Those coming to or going from Barangay Pili, Banilad and Ranzo shall use Guinhawa- Sta. Isabel- Cacawan Road as an alternative route.

**EFFECTIVITY.** This Executive Order shall take effect immediately.
