EXECUTIVE ORDER NO.027-2017

AN ORDER CREATING THE PROJECT MANAGEMENT COMMITTEE FOR THE ESTABLISHMENT OF FISH LANDING CENTER FOR MUNICIPAL FISHERFOLKS OF MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, under the 1987 Philippine Constitution, the State shall protect the rights of the subsistence fishers esp0ecially local communities, to the preferential use of communal marine and fishing resources, both land and offshore. It shall provide support to such fishers through appropriate technology, research adequate financial, production and marketing assistance, and other services. The State shall also protect, develop, and conserve resources (Section 7, Article VIII);

WHEREAS, the Fisheries Code of 1987 mandates the government to provide for post-harvest facilities for the development of municipal fisheries;

WHEREAS, the Bureau of Fisheries and Aquatic Resources (BFAR) and the National Anti-Poverty Commission has a joint program with the establishment of the Fish Landing Center (FLC) as integral part of the BFAR's Targeted Action to Reduce Poverty and Generate Economic Transformation (TARGET) program;


WHEREAS, the Municipality of Pinamalayan, Oriental Mindoro is identified as one of the beneficiaries of sites where fishing land centers will be established.

WHEREAS, there is a need to organize a multi-stakeholders Fish Landing project Management Committee at the municipal level, composed of the LGU, BFAR, fisherfolks organization, NAPC, and other concerned agencies and private sector to act as decision- making, coordinating and consultative body, to include supervision and monitoring of the sub-committees that shall conduct technical and social preparations for the establishment of fish landing center/s.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. PURPOSE. The Fish Landing Project Management Committee is hereby constituted to facilitate the municipal level technical and social preparations in relation to the establishment of FLC. The SC will be temporary in nature and will automatically cease once the Co-Management Structure for the FLC is formed and constituted.

New committees may be organized as the need arises.

The Office of the Municipal Agriculturist shall served as the Secretariat of the FLC-PMC.

Other interested parties with similar objectives who signify willingness to take part in the implementation of the program may be invited to join as members to the FLC-PMC as it deems it necessary.

Section III. POWERS AND FUNCTIONS. The FLC-Project Management Committee shall perform the following functions:

- 1. Check and ensure that technical and social preparations are being implemented;
- 2. Enable all project stakeholders to participate in the planning and implementation of the program;
 - 3. Define and agree on a mechanism for coordination among stakeholders;
 - 4. Select the site for the FLC based on established processed and criteria;
 - 5. Resolve issues elevated by the sub-committees;
 - 6. Approve Intervention Plan for the Fish Landing Centre (FLC)
 - 7. Approve the Guidelines for the management system of the FLC;
- 8. Spearhead the formation and organizing of the co-management Body to manage the FLC.

Section IV.SUBCOMMITTEES. Two sub-committees shall be created. One will ensure technical preparations and the other one will ensure the implementation of social preparations. Each sub-committee shall be multi-sectoral in composition and shall serve as the venue for the formulation and implementation of a concrete plan.

The Subcommittee for Technical Preparation shall ensure the technical aspects:

1. Documentation of land tenure requirements of the selected sites;

- 2. Review and adoption of memorandum of agreement between BFAR,PFDA and LGU;
- 3. Review pro-forma ordinance granting permission for use of LGC and endorse to the Sangguniang Bayan.

The Subcommittee for Social preparations shall:

- 1. Conduct community profiling;
- 2. Facilitate community organizing of target fishinbg communities;
- 3. Draft the development intervention plan for the FLC;
- 4. Draft management systems of the FLC;
- 5. Capacity building of fisherfolks organization.

The immediate activities and initial work plan of the Project Management Committee for the establishment for the FLC is attached herein as Annex 1.

Section V. FUNDING. Expenses incidental to the operationalization of this Executive Order shall be charged under any available funds of this Local Government.

Section VI. EFFECTIVITY. This Executive Order shall take effect upon signing and shall be terminated upon completion of the FLC, unless otherwise extended by the BFAR,NAPC, and the LGU.
