EXECUTIVE ORDER NO. 028-2017

AN ORDER CREATING THE PEOPLE'S SURVIVAL FUND (PSF) - TECHNICAL WORKING GROUP (TWG) FOR THE PREPARATION OF PSF PROJECT PROPOSALS OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, the Climate Change Vulnerability Index (CCVI) 2015 ranked the Philippines 8th most vulnerable country susceptible to the severe impact of climate change;

WHEREAS, the Philippines is located in the Pacific Ring of Fire making it highly vulnerable to natural hazards, experiencing an average of 20 typhoons per year, five (5) of them are said to be destructive;

WHEREAS, Republic Act No. 9729 known as "Climate Change Act of 2009" as amended by the Republic Act No. 10174 that created the Climate Change Commission (CCC) mandates the Local Government Units (LGU) to formulate their respective Local Climate Change Action Plans (LCCAP) to mitigate and adapt to climate change risks;

WHEREAS, Local Government Code (LGC) of 1991 vests in all Local Government Units the responsibility to promote and safeguard the general welfare of its constituents;

WHEREAS, the Municipality of Pinamalayan lies on the path of the frequent typhoons and other weather-related hazards and have repeatedly experienced massive destruction:

NOW THEREFORE, I, ARISTEO A. BALDOS, JR, Municipal Mayor of Pinamalayan, Oriental Mindoro, by virtue of the power and authority vested in me by law, do hereby order the creation of People's Survival Fund Technical Working Group of Pinamalayan, Oriental Mindoro as follows:

Section 1. CREATION. There is hereby created a People's Survival Fund (PSF) – Technical Working Group (TWG) composed of municipal personnel from the Municipal Government of Pinamalayan.

Section 2. COMPOSITION. THE PSF – TWG shall be composed of the following:

Section 3. DUTIES AND FUNCTIONS.. The PSF-TWG shall perform the following role and functions:

- 1. Actively participate in the preparation and formulation of the PSF proposal of the municipality;
- 2. Provide general guidance and technical feedback on projects activities and relative to the priorities of the municipal government;
- 3. Identify and prioritize the appropriate adaption measures based on sound and knowledge of the local community;
- 4. Undertake climate programming by mainstreaming the prioritized climate adaption measures into the local developments plans;
- 5. Participate in the review, critiquing and finalization of the project proposal.

Section 4. SECRETARIAT.-The Municipal Disaster Risks Reduction and Management Office shall serve as secretariat of PSF-TWG.

Section 5. REPEALING CLAUSE. All order, issuances, rules and regulation or parts thereof, which are inconsistent with this Executive Order are hereby revoked or modified accordingly.

Section 6. EFFECTIVITY. This Executive Order shall take effect immediately.
