### EXECUTIVE ORDER 029-2018

AN ORDER CREATING THE TEAM WHO WILL UNDERTAKE THE FUNCTIONS OF THE TASK FORCE FOR THE EFFECTIVE IMPLEMENTATION OF REPUBLIC ACT NOS. 9003 AND 9211 AND MUNICIPAL ORDINANCE NOS AND 4-a-92. 04-2014, AS AMENDED AND MUNICIPAL EXECUTIVE ORDER NO. 025-2017 IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Local Government Code of the Philippines (1991) enjoins LGU's to enforce sanitation laws;

WHEREAS, Presidential Decree No. 1152 otherwise known as Philippine Environmental Code of (1997) established specific environmental management policies and prescribed environment quality standards for air and water, land use management, natural resources management and conservation, enforcement and guidelines for waste management, Sec. 23 particularly states that the "preparation and implementation of waste management programs shall be required in all provinces, cities and municipalities;;

WHEREAS, pressing issues and concerns related to Solid Waste Management in the Municipality of Pinamalayan require management actions as mandated by RA 9003;

WHEREAS, the Municipality of Pinamalayan is committed in promoting a healthful environment and in protecting its citizens from the hazards of tobacco smoke;

WHEREAS, it is deemed necessary to create a Team that will be responsible for the strict implementation of the aforesaid laws and municipal ordinances to ensure the attainment of environment friendly place for its populace.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., Municipal Mayor, by virtue of the powers vested in me by Law, do hereby order the creation Team who will undertake the functions of the TASK FORCE for the effective implementation of RA 9003 "AN ACT PROVIDING FOR AN ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM" and RA 9211 "THE TOBACCO REGULATION ACT OF 2003" and relevant municipal ordinances:
