EXECUTIVE ORDER NO. 032-2016

AN ORDER CREATING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL PRESCRIBING ITS POWERS AND FUNCTIONS THEREOF.

WHEREAS, the Department of the Interior and Local Government in the Memorandum Circular No. 98-227 supplemented by Memorandum Circular No. 99-106 dated June 22, 1999 mandate the creation of the Municipal anti-Drug Abuse Council;

WHEREAS, the proliferating use of illegal drugs significantly contributed to the incidents of crimes,

WHEREAS, the Municipality of Pinamalayan support the program on war against illegal drugs;

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR., by virtue of the power vested in me by law, do hereby order the creation of Municipal Anti-Drug Abuse Council.

Section 2. Powers and Functions. The council shall exercise the following powers and functions.

- a. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning implementation and evaluation of programs on drug abuse prevention.
- b. Provide for an effective mechanism for their coordination of existing services and programs and those which might be develop in the immediate future;
- c. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
- d. Perform other related responsibilities as may be assigned by competent authorities;

Section 3. Effectivity. This order shall take effect immediately.
