EXECUTIVE ORDER NO. 32-2017

AN ORDER REORGANIZING THE MAMAMAYANG AYAW SA ANOMALYA, MAMAMAYANG AYAW SA ILIGAL NA DROGA (MASA MASID) GROUP OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Memorandum Circular No. 2017-112 of Department of the Interior and Local Government provides the Revised Guidelines on the Implementation of Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw sa Iligal na Droga (MASA MASID);

WHEREAS, Memorandum Circular No. 2016-116 of Department of the Interior and Local Government entitled "Implementation of Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw sa Iligal na Droga (MASA MASID) Program" is in line with the priorities of the current administration to rid the country of illegal drugs, criminality, and corruption;

WHEREAS, the Municipal Government of Pinamalayan realizes the role of MASA MASID in protecting the community from violent extremism and other threats to peace and security and preventing the entry of groups or individuals who wish to spread fear in it.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., by the power vested upon me do hereby order the reorganization of Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw sa Iligal na Droga (MASA MASID) Group, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan that;

Section I. COMPOSITION and FUNCTIONS.

A. COMPOSITION. The reorganization of MASA MASID Group shall be composed of the following:

1. Oversee the implementation of the project;
2. Mobilize the support of the Local Government Units (LGUs) and key stakeholders; and
3. Monitor the implementation of the project.

Section II. TECHNICAL WORKING GROUP and FUNCTIONS.

A. TECHNICAL WORKING GROUP. The TWG in the reorganization of MASA MASID Group shall be composed of the following:

B. FUNCTIONS. The TWG of the MASA MASID Group shall perform the following duties and functions:

1. Establish the MASA MASID modes of reporting in the municipal level and put in place an effective reporting mechanism to ensure that reports are properly acted upon;
2. Consolidate reports coursed through the modes of reporting, validate submitted reports and refer to concerned agencies if needed;
3. Organize and mobilize the MMTs;
4. Organize and mobilize MASA MASID Volunteers (MMV);
5. Ensure the effective implementation of MASA MASID Activities; and
6. Provide effective and regular monitoring and evaluation mechanism.

Section III. SECRETARIAT - The Municipal Anti-Drug Abuse Council (MADAC) and Municipal Peace and Order Council (MPOC) Representative shall provide secretariat support to the National Secretariat which is the DILG.

Section IV. EFFECTIVITY - This order shall take effect immediately.
