EXECUTIVE ORDER NO. 032- 2020

AN ORDER CREATING THE MONITORING TEAM FOR ROAD CLEARING PROGRAM IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, DILG Memorandum Circular No. 2020-145 provides for the resumption of road clearing operation depending on the quarantine classification of the local government units, giving 60 calendar days for local government units to comply with the Presidential directive;

WHEREAS, DILG Memorandum Circular No. 2020-027 states that all Punong Barangays shall be in charge of the conduct of road clearing operations in barangay roads and minor public-use streets within their jurisdiction, as well as the maintenance of other local roads turned over by the municipal government;

WHEREAS, the aforementioned circular directs all Mayors to monitor the implementation of road clearing operations at the barangay level;

WHEREAS, the creation of Monitoring Team is indispensable to ensure compliance with laws, circulars and ordinances relevant to road clearing of illegal structures and obstructions.

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in my by law, do hereby order the creation of Monitoring Team for Road Clearing Program in the Municipality of Pinamalayan, Oriental Mindoro;

Section 2. DUTIES AND FUNCTIONS. The Monitoring Team shall perform the following duties and functions:

- 1. Monitor the implementation of the road clearing program at the barangay level and submit monthly monitoring report every 2nd working day of the ensuing month;
- 2. Ensure compliance and cooperation of barangay captains;
- 3. Review the Monthly Report on Road Clearing submitted by the barangay captains;
- 4. Recommend strategies and activities to the Local Chief Executive for the sustainability of road clearing program;
- 5. Perform other functions as may be deemed necessary.

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately.
