EXECUTIVE ORDER NO. 033-2016

ORGANIZATION OF SPECIAL DRUG EDUCATION CENTER TEAM

WHEREAS, Section 46 R.A.9165, otherwise known as the Comprehensive Dangerous Drug Act 2002, provides that "With the assistance of the Board, the department of the Interior and Local Government (DILG), the National Youth Commission (NYC), and the Department of Social Welfare and Development (DSWD) shall establish in each of its provincial office a special education drug center for out-of-school youth and street children."

WHEREAS, DILG Memorandum Circular 2006-150 dated November 7, 2008 enjoins Municipal Government to organize Special Drug Education Center Team (SDECT).

WHEREAS, the SDEC is a community based facility, which serves as a venue in promoting preventive and developmental services for the out-of-school youth (OSY) and street children. It shall promote programs for drug abuse prevention with the end view of educating the OSY and street children regarding the pernicious effect of drug abuse thereby contributing to their total development as self-reliant and socially responsible members of the society.

WHEREAS, local government units must pursue an intensive and unrelenting campaign against trafficking and use of dangerous drugs and other similar substances through an integrated system of planning, implementation and enforcement of anti-drug abuse policies, programs and projects;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., by virtue of the powers vested in me as the Local Chief Executive of Pinamalayan, Oriental Mindoro, do hereby organize the SPECIAL DRUG EDUCATION CENTER TEAM (SDECT).

SECTION 2. - RESPONSIBILITIES OF SDEC TEAM

- 1. Develop and implement programs and service on drug abuse prevention among the OSY and street children and coordinate/integrate/utilize related activities/services and other agencies;
- 2. Operate and manage the SDEC according to established guidelines set by the DSWD;
- 3. Provide the facilities, funds, personnel, supplies, materials and equipment necessary in the management target clientele and manage their cases;
- 4. Identify target clientele and manage their cases;
- 5. Ensure that the SDEC complies with the standards developed on the operation of the center, as an approved by the Dangerous Drugs Board (DDB);
- 6. Organize and mobilize volunteers to assist in the implementation of drugs abuse prevention program in coordination with the MSWDO; and
- 7. Conduct regular monitoring and evaluation of the SDEC following the standards set, including documentation of the operation SEEC in the implementation of drug abuse prevention program.

SECTION 3. FUNDING. Expenses relative to the activities of the Team shall be charged partly against Peace and Order Fund of the Municipality.

SECTION 4. EFFECTIVITY. The order shall takes immediately.
