EXECUTIVE ORDER NO. 033-2017

"AN ORDER CREATING THE MUNICIPAL PERFORMANCE CHALLENGE FUND (PCF) PROJECT IMPLEMENTATION AND MANAGEMENT TEAM OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO"

- 3. Facilitate the preparation and submission to the DILG Regional office quarterly progress reports of physical accomplishment and fund utilization, and report of disbursements verified by the Local COA;
- 4. Upon completion of the project, facilitate the preparation and submission to DILG Regional Office project completion report;
- 5. Performs such other functions related to PCF implementation and management as may be prescribe by competent authorities.
