EXECUTIVE ORDER NO. 034-2018

AN ORDER REORGANIZING THE MEMBERSHIP OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, there is a need to reorganize the People's Law Enforcement Board of Pinamalayan, Oriental Mindoro in accordance with NAPOLCOM MC 2016-002;

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR. by virtue of the power vested in me by law do hereby order and direct the reorganization of the People's Law Enforcement Board (PLEB) of Pinamalayan, Oriental Mindoro as follows:

Section I. Composition. The PLEB shall be composed of the following:

ATTY. GAUDENCIO SADICON	Member of the Bar
MRS. ILUMINADA MARTIN	Women Sector

The Chairman of the PLEB shall be elected from among its members:

Section II. Functions, Powers and Duties. The People's Law Enforcement Board has the power to hear and adjudicate all citizen's complaints formally filed with, or referred to it, against any uniformed member of the PNP, and, if warranted, impose the corresponding penalty.

Section III. Term of Office. The term of office of the members of the PLEB shall be for a period of three (3) years from assumption of office. Such member shall hold office until his/her successor shall have been chosen and qualified.

Section III. Effectivity. This Executive Order shall take effect immediately.
