EXECUTIVE ORDER NO. 034-2020

AN ORDER ESTABLISHING FIRECRACKER AND OTHER PYROTECHNIC DEVICES ZONES AND FIREWORKS DISPLAY AREA IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, Republic Act No. 7183 otherwise known as "Act Regulating the Sale, Manufacture, Distribution and Use of Firecracker and other Pyrotechnic Devices" mandates the Local Government Unit to observe the manufacturing, sale, distribution, and use of firecrackers and pyrotechnic devices including the strict compliance to safety precautions, rules and regulation of manufacturer, distributor, seller and user;

WHEREAS, DILG Memorandum Circular No.2018-216 reiterated the DILG Memorandum Circular No. 2017-105 which provides the regulation and control of the use of firecrackers and other pyrotechnic devices;

WHEREAS, to forestall firecracker related injuries and casualties, it is deemed necessary to provide clear guidelines on the regulation and control of the use of firecracker and other pyrotechnic devices in this municipality.

NOW THEREFORE, by the authority given to Local Chief Executive to promulgate the necessary rules and regulations within their territorial jurisdiction, **I, ARISTEO A. BALDOS, JR.**, Municipal Mayor of Pinamalayan by virtue of the powers vested in me by law, do hereby order the establishment of firecrackers and pyrotechnic devices zone in the Municipality of Pinamalayan, Oriental Mindoro:

SECTION I. Firecracker and other pyrotechnic devices zone and fireworks display area:

- a. Upon recommendation of Municipal Peace and Order Council during its meeting conducted on December 2, 2020, the designated area/zone for selling allowed firecrackers and other pyrotechnic devices shall be permitted only at ***Burgos Street Extension adjacent to Juan Morente Senior Memorial Pilot School, Zone II, Pinamalayan, Oriental Mindoro*** in coordination with the Philippine National Police and Bureau of Fire Protection;
- b. The Barangay Captain shall designate one firecracker zone in their respective area of jurisdiction and provide Mayor's Office, Philippine National Police and Bureau of Fire Protection a copy of such designation;

SECTION II. Permit. A permit shall be secured for the conduct of a community fireworks display specifying the date, time and area of fireworks display.

SECTION III. PENALTIES. Any person who sells, distributes, uses firecrackers and other pyrotechnic devices other than designated areas/zone shall be punished in accordance with the provision of Republic Act 7183.

SECTION IV. EFFECTIVITY. This Order shall take effect immediately.
