### **EXECUTIVE ORDER NO. 035-2020**

#### **AN ORDER CREATING THE MUNICIPAL VERIFICATION COMMITTEE AND BARANGAY VERIFICATION COMMITTEE FOR THE LISTAHANAN VALIDATION IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, the Department of Social Welfare and Development (DSWD), through the National Household Targeting Office, is programmed to update the database of poor households through the conduct of Listahanan nationwide household assessment this year;

**WHEREAS**, in order to have an orderly, effective and comprehensive implementation of the nationwide household assessment, the DSWD shall be needing the cooperation and assistance of the Local Government Units (LGU) officials, in all areas for household assessments;

**WHEREAS**, DILG Memorandum Circular dated November 3, 2020 enjoins all Local Chief Executives to create Municipal and Barangay Verification Team;

**WHEREAS**, during the meeting of the Municipal Development Council held last November 30, 2020, the body recommended the composition of Municipal and Barangay Verification Committee.

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR.**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the creation of Municipal Verification Committee and Barangay Verification Committee for the Listahanan Validation in the Municipality of Pinamalayan, Oriental Mindoro.

#### **Section 1. COMPOSITION:**

A. The Municipal Verification Committee shall be composed of the following:

<b>MR. JOHN DAVE M. DELOS SANTOS</b>	- Representative of the Local Chief Executive
<b>MS. GRACE EUNICE F. FABELLA</b>	- MSWDO Representative
<b>MR. KEANU M. ORACION</b>	- MPDO Representative
<b>MS. ANA D. LOZANO</b>	- President, Local Council for Women
<b>MR. EDWIN C. ANDAL</b>	- President, KASAMA, Inc

B. The Barangay Verification Committee shall be composed of the following:

**Barangay Captain**  
**Barangay First Councilor**  
**Barangay Councilor– Chairperson of Social Services/Welfare (Health Education, Women and Family)**  
**CSO Representative in the Barangay**

**Section 2. DUTIES AND FUNCTIONS.** The Municipal and Barangay Verification Committee shall work with Listahanan Area Supervisor to resolve the grievances relative to the exclusion from the identified initial poor households, inclusion of non-poor household in the list, misspelled or incorrect household information. They shall submit report to the DSWD.

**Section 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
