**EXECUTIVE ORDER NO. 036-2016**

**AN ORDER CONSTITUTING THE MUNICIPAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (MESWMB)**

**WHEREAS**, Republic Act 9003" An Act Providing for an Ecological Solid Waste Management Program creating the necessary Institutional Mechanisms and Incentives, declaring certain acts prohibited and providing penalties, appropriating funds, therefore, and for other purposes was promulgated on January 25, 2001 with the view to generate greater multi-sectoral interest and partnership in addressing the garbage problem in the country today;

**WHEREAS**, DILG MC 2001-19 dated March 2, 2001 directs the creation of an Ecological Solid Waste Management Board (ESWMB) at the Provincial, Municipal and City levels, in conformity with RA 9003.

**WHEREAS**, the increasing volume of garbage is posing a serious threat to the general welfare and health of the people as well as to the integrity of the environment;

**WHEREAS**, the health and environmental problem requires with most attention and cooperation among the concerned national government agencies, local government units, business community, civil society and the people in general;

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR**, Municipal Mayor, by virtue of the power vested in me by law do hereby order the creation of Municipal Ecological Solid Waste Management Board (ESWMB).

**Section I. Composition.** The council shall be composed of the following

**Section 2. Powers and Functions.** The Municipal Ecological Solid Waste Management Board shall exercise the following powers and functions:

- A. Develop the Municipal Solid Waste Management Plan to ensure long term solid waste management as well as, integrate the various Solid Waste Management Plans and Strategies of component barangay;
- B. Adopt measures to promote and ensure the viability and - effective implementation of Solid Waste Management Programs in all component barangay;
- C. Monitor the implementation of the Municipal Solid Waste Management Plan, through the component barangays, and in cooperation with concerned NGOs
- D. Adopt specific revenue generating measures to promote the viability of the solid waste management plan;
- E. Convene regular meeting for purpose of planning and coordinating for implementation of the solid waste management plans of component barangays;
- F. Oversee the implementation of the Municipal Waste Management Plan;
- G. Review every 2 years, or as need arises, the Municipal Solid Waste Management Plan for purposes of ensuring the sustainability, viability effectiveness and relevance in relation to local and international development in the field of solid waste management;
- H. Develop specific mechanics and guidelines to implement the Municipal Solid Waste Management Plan;
- I. Recommend to appropriate local government authorities specific measures of proposal for franchise or build-operative-transfer agreements with duly recognize institutions to provide either exclusive or non-exclusive authority for the collection, transfer, storage, processing, recycling or disposal of municipal solid waste;
- J. Provide for necessary logistical and operational support to components barangays;

- K. Recommend measures and safeguards against pollution and the preservation of the natural ecosystem;
- L. Coordinate the efforts of component barangays in the implementation of the municipal solid waste management plan; and
- M. Call on any concerned agency of sector, as it may deem necessary, to support or other appropriation action;

**Section 3. Secretariat.** The Municipal Environment and Natural Resources Office (MENRO) shall be the Secretariat.

**Section 4. Effectivity.** This Executive Order shall take effect immediately
