EXECUTIVE ORDER CREATING THE MUNICIPAL NUTRITION CLUSTER TO BE COMPOSED OF THE MEMBERS OF THE MUNICIPAL NUTRITION COMMITTEE.

**WHEREAS**, various natural and man- made emergencies disrupt the lives of affected people, compromising their health and nutritional status

**WHEREAS**, such threat could be mitigated through a proper and well- coordinated disaster management system

**WHEREAS**, the National Disaster Risk Reduction and Management Council though NDCC Circular 2007-05, mandates the institutionalization of the cluster approach in such a system, the designation of cluster leads and their terms reference.

WHEREAS, Regional Memorandum Circular mandate the organization of local Nutrition Cluster to be composed of the members of the Local Nutrition Committee

**WHEREAS**, Regional Nutrition Committee Resolution No. 2 series 2014 created the Regional Nutrition Cluster to facilitate the Nutritional Management and preparedness in time of disaster and emergencies

- 1. Ensure that the Nutritional status of the effected population will not worsen.
- 2. Facilities strategic collaboration & comprehensive of emergency management, resource mobilization and integration of cross-cutting nutrition concerns with other cluster.
- 3. Conduct rapid nutritional assessment.
- 4. Ensure delivery of quality package of nutrition interventions.
- 5. Ensure that foods provided and distributed are nutritionally adequate
- 6. Conduct training and other various capacity building activities
- 7. Provide nutrition counselling to affected population;
- 8. Establish and promote coordinate and management mechanism

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately.
