## EXECUTIVE ORDER NO. 004-2020

AN ORDER CREATING THE MULTI-STAKEHOLDER INSPECTORATE TEAM (MSIT) FOR THE SUSTAINABILITY EVALUATION TESTING AND SUSTAINABILITY PERFORMANCE AND ACTUAL UTILIZATION OF COMPLETED SUB-PROJECT OF CYCLE 1 OF KALAH-CIDSS NCDDP IN THE MUNICIPALITY OF PINAMALAYAN

WHEREAS, KALAH-CIDSS Program aims to empower local communities through improve participation in local governance and involvement in the preparation and implementation of poverty reduction projects and consists, among others, the provision of grants to support prioritized barangay sub-projects in the participating municipalities;
