**EXECUTIVE ORDER NO.046-2016**

**AN ORDER CREATING THE EXPANDED UGNAYAN NG BARANGAY AT SIMBAHAN (UBAS) TECHNICAL WORKING GROUP OF PINAMALAYAN, ORIENTAL MINDORO.**

**WHEREAS**, the Department of Interior and Local Government Memorandum Circular No. 2016-116 mandates the creation of Expanded UBAS Technical Working Group to serve as the social facilitator in the MASA MASID Program;

**WHEREAS**, in the Mamayang Ayaw sa Anomalya Mamamayang Ayaw sa Iligal na Droga (MASA MASID) Program, the faith-based organizations and community volunteers will be engaged through the Ugnayan ng Barangay at Simbahan (UBAS ) to address the long standing battle against criminality, corruption and illegal drugs

**WHEREAS**, creation of Expanded UBAS Technical Working Group is vital in ensuring an effective war against illegal drugs and illegal drug-related crimes;

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR**, Local Chief Executive of the Municipality of Pinamalayan, by virtue of the powers vested in me, do hereby order and direct the creation of Expanded Ugnayan ng Barangay at Simbahan (UBAS) Technical Working Group of Pinamalayan, Oriental Mindoro.

**Section 2. DUTIES AND FUNCTION.**

- a. Promote MASA MASID as a mechanism to respond to the needs of this LGU;
- b. Convene, organize, train and mobilize the MASA MASID Team at Barangay Level;
- c. Provide technical assistance to MASA MASID Teams in every barangay
- d. Implement a systematic monitoring and reporting mechanism.

**Section 3. INSTITUTIONAL ARRANGEMENTS.**

- A. DILG Municipal Field Offices, as Chair of the Expanded UBAS TWG shall:
  - a. Spearhead the organization and mobilization of the Expanded UBAS C/M TWG and MMT;
  - b. Conduct orientation/training of the MMTs;
  - c. Maintain a registry of the MMTs; and
  - d. Oversee the implementation of the MASA MASID Program within their jurisdiction and ensure its successful implementation.

- B. Municipal Anti-Drug Abuse Council (MADAC) Representative
- a. Work closely with the DILG Municipal Field Office on the implementation of MASA MASID Program;
  - b. Provide technical and administrative support; and
  - c. Act as secretariat
- C. The ABC President as Member of Expanded UBAS TWG shall:
- a. Assist in the organization and orientation of MASA MASID Team;
  - b. Collaborate with the MMTs in the implementation of MASA MASID;
  - c. Assist in coordinating with partner organizations for the provision of aftercare and livelihood program for the RDDs; and
  - d. Conduct advocacy and information campaign against illegal drugs within their jurisdiction.
- D. The members of the Faith-Based and Inter-Faith Organizations as member of the Expanded UBAS TWG shall:
- a. Assist in organizing and orienting the MMTs;
  - b. Mobilize the support of faith-based organizations;
  - c. Spearheaded the advocacy and education campaigns in the community;
  - d. Assist in the implementation of Community-Based Rehabilitation Program; and
  - e. Assist in the implementation of community-based reintegration of the Recovering Drug Dependents back to the communities.
- E. The Local PNP as member of the Expanded UBAS TWG shall:
- a. Assist in the organization and in capacitating the MASA MASID Teams;
  - b. Provide technical assistance; and
  - c. Assess the reports submitted by the MMTs, and take necessary actions including but not limited to, filing of cases and/or referral of drug users for counselling and/or rehabilitation, depending on the frequency of the use of illegal drugs.

**Section 4. EFFECTIVITY.** This Executive Order shall take effect immediately.
