EXECUTIVE ORDER NO. 053 – 2016

**AN ORDER REORGANIZING THE MUNICIPAL COUNCIL FOR WOMEN
PRESCRIBING ITS POWER AND FUNCTION THEREOF.**

WHEREAS, the Department of Interior and Local Government in its Memorandum Circular No. 2001 – 163 mandates the creation of the Municipal Council for Women.

WHEREAS, the Department of the Interior and Local Government in its Memorandum Circular No. 2006 – 125 dated September 21, 20

NOW, THEREFORE, I, ARISTEO A. BALDOS, JR. by virtue of the power vested in me by law do hereby order;

Section I. Creation of the Municipal Council for Women. A Municipal Council for Women is hereby created and for this purpose hereinafter referred to as the Council;

- b. Work for the integration of the PFLCW, Inc. advocacy agenda and other relevant concerns in the provincial development plans and programs.
- c. Conduct meeting as the need arises.
- d. Coordinate, collaborate, recommend and provide the necessary support to NCRFW (now Philippine Commission of Women) and PFLCW, Inc. in the implementation of its programs.
- e. This order shall take effect immediately upon approval hereof.

Section IV. Effectivity. This Executive Order shall take effect immediately.
