EXECUTIVE ORDER NO.006-2020

AN ORDER CREATING TASK FORCE, TECHNICAL WORKING GROUP AND SECRETARIAT WHO WILL BE RESPONSIBLE FOR THE DRAFTING AND FORMULATION OF TRICYCLE ROUTE PLAN OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Local Government Code devolved to all municipal governments through their respective Sanggunians, the power to regulate the operations of tricycles/pedicabs and to grant franchises for the operation thereof within their territorial jurisdiction;

WHEREAS, DILG Memorandum Circular No. 2020-036 directed all Local Government Units to review all existing tricycle and pedicab routes within the area of jurisdiction and modify it accordingly pursuant to the absolute prohibition imposed under the aforementioned issuance;

WHEREAS, to effectively carry out its devolved power, there is a need for the Municipal Government of Pinamalayan to create Task Force, Technical Working Group and Secretariat who will be responsible for the drafting and formulation of Tricycle Route Plan of Pinamalayan, Oriental Mindoro.

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., Local Chief Executive of the Municipality of Pinamalayan, Province of Oriental Mindoro, by virtue of the power vested in me by law, do hereby order the creation of Task Force for the formulation of Tricycle Route Plan of the Municipality of Pinamalayan, Oriental Mindoro, as follows:

Section 1. CREATION. All Municipalities shall create a task force which is separate and distinct from its Tricycle Regulatory Board or unit.

Section 2. COMPOSITION. The Task Force shall be composed of the following:

Section 3. FUNCTION. The Task Force shall perform the following duties and functions:

1. Conduct meetings, public consultations and hearings with stakeholders, and survey/ocular inspection of the zone/area of tricycle operations with special focus on the following:
 - a. Rationalizing the authorized routes of all tricycles and pedicabs to ensure that they are banned from national highways;
 - b. Identification of national roads within the area of jurisdiction of the LGU;

- c. Determination of the portions of the national highway presently used or proposed to be traversed by tricycles only if there are no alternative routes available.
2. Draft or update the Tricycle Route Plan (TRP) within 30 days from the issuance of this memorandum, the committees shall come up with a TRP which shall be the basis of a subsequent ordinance.
