EXECUTIVE ORDER NO. 07 - 2017

AN ORDER REORGANIZING THE COMPOSITION OF THE ENHANCED PINAMALAYAN SCHOLARSHIP PROGRAM (EPSP) PURSUANT TO THE MUNICIPAL RESOLUTION NO. 039 (A)-2008 AND ORDINANCE NO. 05-2008.

WHEREAS, the Constitution mandates that the State shall protect and promote the rights of all citizens to quality education thus making it accessible to all;

WHEREAS, to support this endeavour, the Sangguniang Bayan of Pinamalayan, thru Ordinance No. 01-94 established the Pinamalayan Scholarship Program;

WHEREAS, to fully realize the good intentions for which the program was established, the said Ordinance was amended through Resolution No. 039 (A) - 2008 and Ordinance No. 05-2008 entitled as "An Ordinance Establishing the Enhanced Pinamalayan Scholarship Program and Providing Funds thereof."

WHEREAS, in view of the retirement of some of the members of the previous committee, as well some changes in the new set of administration, it is imperative for the reorganization of the Municipal Scholarship Committee;

NOW THEREFORE, I, ARISTEO A. BALDOS, JR., by the power vested upon me do hereby create for the purpose, a new composition of the Municipal Scholarship Committee, as it is hereby ordained by the Sangguniang Bayan of Pinamalayan that;

Section I: Enhanced Pinamalayan Scholarship Program (EPSP) shall be administered by the Municipal Scholarship Committee with the following composition.

- a) Formulate rules and regulations in the conduct of selection of qualified applicants.
- b) Adopt minimum qualification requirements as basis for the selection.
- c) Make recommendations to enhance the very intention of the program.

Section IV. HONORARIUM – The committee shall be entitled to receive a reasonable honorarium to be determined by the Sangguniang Bayan.

Section V. EFFECTIVITY – This order shall take effect immediately.
