**EXECUTIVE ORDER NO. 07-2018**

**AN ORDER PROVIDING FOR THE EXPANDED COMPOSITION OF THE LOCAL ACQUIRED IMMUNE DEFICIENCY SYNDROME (AIDS) COUNCIL IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO**

**WHEREAS**, Executive Order No. 014-2017 issued last April 11, 2017 orders the reorganization of the Local Acquired Immune Deficiency Syndrome (AIDS) Council in the Municipality of Pinamalayan, Oriental Mindoro;

**WHEREAS**, there is a need to expand the composition of Local AIDS Council to strengthen the campaign and program for prevention and control of HIV/AIDS;

**NOW THEREFORE, I, ARISTEO A. BALDOS, JR.**, Municipal Mayor of Pinamalayan, by virtue of the power vested in me by law do hereby order the expansion of the composition of Local Acquired Immune Deficiency Syndrome (AIDS) Council in the Municipality of Pinamalayan, Oriental Mindoro as follows:

1. Assist the Sangguniang Bayan in setting the direction on HIV and AIDS related programs and activities.
2. Institutionalize LGU and NGO Partnership at the local level by way of putting in place ordinances, policies and resources to HIV and AIDS projects and activities.
3. Establishment of coordinating body installing plans and allocating resources in support of the plans; and
4. Oversee an integrated and comprehensive approach to HIV/AIDS prevention and control in the locality through the programs and projects recommended and issued by the Philippine National AIDS Council.

**Section III. SECRETARIAT.** The Municipal Health Office shall serve as the Secretariat of Local Acquired Immune Deficiency Syndrome (AIDS) Council.

**Section IV. EFFECTIVITY.** This Executive Order shall take effect immediately.
