EXECUTIVE ORDER NO. 08-2018

AN ORDER PROVIDING FOR THE EXPANDED COMPOSITION OF THE MUNICIPAL HEALTH BOARD (MHB) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, Executive Order No. 012-2016 issued last July 4, 2016 orders the reconstitution of the membership of Municipal Health Board (MHB) in the Municipality of Pinamalayan, Province of Oriental Mindoro;
