EXECUTIVE ORDER NO. 024-2021

AN ORDER RECONSTITUTING THE PROJECT MONITORING COMMITTEE (PMC) OF THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

WHEREAS, the Project Monitoring Committee (PMC) of the Municipality of Pinamalayan, Oriental Mindoro was reorganized by virtue of Executive Order No. 033-2020 issued on November 27, 2020;

WHEREAS, the Municipal Development Council during council meeting held last August 26, 2021 at East District Conference Hall recommended the reconstitution of the Project Monitoring Committee to replace non-active members of the PMC;
