EXECUTIVE ORDER NO. 025-2021

AN ORDER CREATING THE MUNICIPAL TRAINING TEAM FOR STRENGTHENING INSTITUTIONAL CAPACITIES OF BARANGAY ANTI-DRUG ABUSE COUNCIL (SICAP-BADAC)

WHEREAS, the Constitution mandates that the government shall promote the quality of life of the people. Towards this end, Section 16 of the Local Government Code of 1991 provides that Local Government Unit (LGU) shall pursue undertakings to improve public morale and maintain peace and order among other equally significant concerns;

WHEREAS, the use of illegal drugs has significantly contributed to the high incidence of heinous crimes and the ill effects of illegal drugs is quite alarming in the peace and order situation of the community;

WHEREAS, pursuant to the Philippine Anti-Drug Strategy (PADS) 2018-2022, there shall be a continuous strengthening of capacities of Barangay Anti-Drug Abuse Councils (BADACs) through the assistance of the Department of the Interior and Local Government (DILG);

WHEREAS, per DILG Advisory dated July 14, 2021 entitled "Implementation of the Roll-out Training Activities on Strengthening Institutional Capacity of Barangay Anti-Drug Abuse Council (SICAP-BADAC), LGUs are mandated to organize Local Training Teams;

WHEREAS, per DILG MIMAROPA Memorandum dated September 22, 2021 the suggested members of the Local Training Teams are:

1. Attend the Regional Roll-Out to be conducted by DILG MIMAROPA Regional Office;
2. Conduct roll-out training to the Barangay Anti-Drug Abuse Councils (BADACs) and equip them with the necessary knowledge, skills and attitude to efficiently perform their duties and functions in relation to:
 - (a) Barangay Drug Clearing Program;
 - (b) Drug Prevention Program;
 - (c) Community-Based Drug Rehabilitation Program, and (d) Aftercare and Reintegration Program;

4. Perform such other functions.
