## EXECUTIVE ORDER NO. 027 - 2021

### AN ORDER REORGANIZING THE CONTACT TRACING TEAM (CTT) IN THE MUNICIPALITY OF PINAMALAYAN, ORIENTAL MINDORO

**WHEREAS**, the Contract Tracing Team of Pinamalayan, Oriental Mindoro was created by virtue of Executive Order No. 012-A-2020 issued on April 18, 2020;

**WHEREAS**, Department Memorandum Order No. 2020-0189 of Department of Health dated April 17, 2020 provides for the updated guidelines on Contract Tracing of closed contacts of confirmed Corona Virus Disease (COVID-2019) Cases;

**WHEREAS**, there is a need to reconstitute the Contract Tracing Team to replace members who are no longer connected with the agency due to retirement and transfer of agency;

**NOW, THEREFORE, I, ARISTEO A. BALDOS, JR.**, Local Chief Executive of Municipality of Pinamalayan, by virtue of the powers vested in me by law, do hereby order the reorganization of Contact Tracing Team in the Municipality of Pinamalayan, Oriental Mindoro:
